**Mohammed Waseem Akhter MD, FACC**, is on faculty at the University of Massachusetts and is an Assistant Professor of Medicine in the Division of Cardiology. He is board certified in General Cardiology, Interventional Cardiology and Endovascular Interventions. He is a fulltime interventional cardiologist at UMASS and he also pursues a busy practice in vascular medicine and is a key member of the Limb-Salvage program at the medical center.

**Iyad Alkhouri, MD**, is a practicing Psychiatrist (Therapist) in Chicago, IL. Dr. Alkhouri graduated from University of Damascus in 1990 and has been in practice for 28 years. He completed a residency at University of North Dakota School of Medicine & Health Sci. He currently practices at University of Michigan and is affiliated with Trinity Medical Center Rock Island Campus.

His writings have appeared in professional journals and in op-eds in major media such as the New York Times and Washington Post. Mr. Rubenstein is a member of the Council on Foreign Relations and the Board of Directors of the Global Health Council and Healing Across the Divides.

**Ahmad Shabsigh, MD, FACS**, is an urologist in Columbus, Ohio and is affiliated with multiple hospitals in the area, including James Cancer Hospital and Solove Research Institute and Ohio State University Wexner Medical Center.
